165 Volumes of Local History Studies Published

The *Maynooth Studies in Local History* series has now a staggering 165 titles published on a range of local history topics presented by exceptionally talented researchers. These publications are of enormous value to genealogists, local historians and many other researchers.

As Series Editor, **Michael Potterton**, puts it very succinctly in his introduction to each of the latest volumes "These half-a-dozen volumes show how the 'local' focus of a *local history* can range from an individual person (Marsden Haddock) to a family (the Mansfields), a street (Day Place), a village (Portmagee), a county (Donegal and Westmeath) and beyond. These six authors have taken their stories from relative obscurity to centre stage". The latter point is makes these real gems for the genealogist.

Published by Four Courts Press in Dublin, Ireland's premier publisher of academic research covering many aspects and periods of Irish and our wider European history. See fourcourtspress.ie

Before delving into the latest six volumes in this hugely important series, we'll make our perennial plea for some philanthropic individual or company to kindly consider sponsoring the complete indexation of the 165 volumes in this wonderful national treasure trove of Irish local history

An index to the detailed information contained within each of these 165 volumes is not currently electronically searchable and thus, it is not readily accessible to current and future researchers. It is important that this issue be addressed in the interest of encouraging further research and, especially, collaborative multidisciplinary research.

The first two, as Michael Potterton indicated, are essentially "county studies" covering Donegal in the northwest and Westmeath in the midlands.



No. 160—DONEGAL: 'The East Donegal Border Petition and the Derry-Donegal Milk War, 1934-38' by Samuel Gary Beckton and published by Four Courts Press (ISBN 978-1-80151-093-6: 86pp: illustrations: p/bk €12.95 Web Price €11.65)

This is a fascinating study of the Protestant population of northeast Donegal which, after partition in 1921, found itself cut off from its coreligionists in the

newly created Northern Ireland. By 1925 with the de facto confirmation of the border along existing county boundaries, their fate was sealed. In November 1934, 7,368 Protestants in east Donegal signed a unionist petition to the British and Northern Irish governments requesting to transfer their region to Northern Ireland. This was a reaction to policies made in the Irish Free State, and later Éire, by Fianna Fáil during the 1930s that resulted in the "Economic War". News of this event spread to numerous newspapers across the British Empire. This book analyses the roots of the petition and looks at those who organised this campaign. No. 161—WESTMEATH: 'Poverty in pre-Famine Westmeath—The findings of the Poor Commission of 1833' by Seán Byrne and published by Four Courts Press (ISBN 978-1-80151-094-3:81pp: illustrations: p/bk

€12.95 Web Price €11.65) The scale of the Great Famine of 1846 has overshadowed the prevalence of extreme poverty in Ireland in the period 1815-45. As economic conditions deteriorated between those years, population increased rapidly. From the 1820s onwards, in the wake of famines and epidemics and an increase in agrarian violence, pressure mounted on the British government to address the problem of poverty in Ireland. In



1833 the government established the Royal Commission for Inquir-ing into the Condition of the Poorer Classes in Ireland. The commission investigated poverty by holding public enquiry sessions, in which the poorest people participated, in seven-teen counties. The reports of those public session provide a detailed account of poverty in 1830s Ireland. This book uses the findings of the Poor Inquiry for Co. Westmeath to give an account of economic and social conditions in the county in the decade before the Famine. **Seán Byrne** is Lecturer Emeritus in Economics, Technological University Dublin.

GDPR & GENEALOGICAL RESEARCH

The Icelandic Data Protection Authority rejected a complaint of a data subject who demanded the enforcement of the data subject's right to erasure against a controller's genealogical database.

The DPA decided the controller's processing was justified pursuant to Article 6(1)(f) GDPR and that it was within its rights to refuse the erasure request pursuant to Article 17(3) GDPR.

GSI BOARD NEWS

The Board of Directors met on **Thursday October** 5th **2023** at 11.00hrs via Zoom. The meeting was chaired by the Leas-Chathaoirleach, **Fíona Tipple, MA, FGSI,** and seven of the nine members were in attendance.

The Board welcomed Eddie Gahan, FGSI, back and he was duly allocated the 'Outreach Programme' portfolio until the AGM in March 2024. All the formalities with the Companies Registrations Office and the Charities Regulatory Authority were finalised during the week before the meeting, including the signing of the 'Code of Conduct' for Board Members.

The Board nominated Fiona Fitzsimons, MA, FGSI and Amb. (Ret) Francis M. O'Donnell, FGSI, as its candidates for the presidency of the Society. Indeed, under Res: 23/10/1733, the Board agreed to permit both candidates to share the eight-year presidential term with four years each, should they agree. This resolution of the Board is to be placed before the College of Fellows for endorsement by electronic ballot held over three days – 28, 29 and 30 October 2023. If the College of Fellows endorse the resolution on the presidency, the Board will announce the decision of the candidates on the sequencing in the November 'Gazette'.

Gerard White, MGSI, Director of Open Meetings & the Lecture Programme, and consultation with Fiona Tipple, MA, FGSI, Director of Archival Services & Education, advised the Board on the Christmas and New Year arrangements as follows: Weekly Drop-Ins – last one in 2023 – Wednesday 20 December 2023 & first one in 2024 – Wednesday 10 January 2024; An Daonchartlann – Archive & Research Centre, closes at 15.00hrs on Wednesday 22 December 2023 and reopens on Wednesday 10 January 2024 at 11.00hrs; and that, the first Evening Open Meeting of the new year will be held on 9 January 2024 at 20.00hrs.

The General Secretary advised the Board that the first **Board Meeting** of 2024 will be held on Thursday 11 January 2024 at 11.00hrs and that the '*Gazette*' will be published during the week ending 20 January 2024.

The General Secretary presented draft amendments to the Constitution of 'Heraldry Ireland' to the Board as a "Stage One Policy Document" with the second stage, consideration of the amendments, scheduled for the November meeting with the third stage and the final adoption ("Fourth Stage") hopefully at the December meeting. The draft amendments to the 2015 document are aimed at streamlining governance, updating objectives, and facilitating greater participation by the members in the operation of the forthcoming 'National Heraldic Survey'.

Gerard Corcoran, MGSI, Director of Digitisation & Genetic Genealogy, requested the General Secretary to arrange for an early meeting of the Irish DNA Atlas Project Management Team (GSI & RCSI) to explore a proposal for participation in an 'Atlantic Arc DNA Project' potentially to be funded under the EU's Interreg Programme.

The General Secretary delivered a written report on behalf of **Laura Price**, **MGSI**, *Convenor of the JGSI 2023 Select Committee*, on the ongoing work on this year's annual journal. It is hoped to have it published on or before 12 Nov 2023 as the finalisation of some of the excellent articles received is still awaited, including biographies.

Preparatory work on the 'National Heraldic Survey' is nearing completion according to the Director of Internet Services, Shane Wilson, MGSI, as testing is of the online collection system is ongoing – ironing out any glitches etc which is taking longer than anticipated.

The next Board Meeting will be held on Thursday 2 November at 11.00hrs via Zoom.

No. 162—KERRY: Portmagee, Co. Kerry—The origins of an Atlantic smuggling village' by Denis Casey and published by Four Courts Press (ISBN 978-1-80151-095-0:86pp:illustrations:p/bk €12.95 Web Price €11.65) This volume — focusing on the immediate region surrounding the Atlantic village of Portmagee — shows how many of our traditional master narratives of Irish history do not stand up to scrutiny when investigated at local level. Christianization, Norman conquests, Cromwellian confiscations, religious persecution and Irish–European smuggling are all examined and shown to be much messier enterprises than popularly imagined, while equally complex was the village's founder, Theobald MacGhee, a smuggler comfortably married into one of Kerry's high-status gentry families. Denis Casey is a graduate of University College Dublin and the University of Cambridge. He has taught medieval and early modern history, literature and manuscript studies at the universities of Maynooth, Helsinki, Cambridge and UCD.

No. 163—CORK: 'Marsden Haddock and the Androides— Entertainment, late Georgian Cork and the wider world' by Neil Cronin and published by Four Courts Press (ISBN 978-1-80151-096-7: 80pp: illustra-

Cronin and published by Four Courts Press (ISBN 978-1-80151-096-7: 80pp: illustrations: p/bk €12.95 Web Price €11.65) Set in the late eighteenth-century, the hero of this story is Marsden Haddock, who devised an exhibition of mechanical ingenuity, the *Androides*. The word *Androide* became synonymous with his devices. In probing the penumbra between man and machine, between the animate and the inanimate, Haddock's lifelike automata and other figures provoked wonder and often fear. This volume positions him and his entertainment as products of the booming war-economy of Cork city, and uses its ready reception as an illustration of the integration of urban Cork into the wider world. Neil Cronin has previously authored *The medical profession and the exercise of power in early nineteenth-century Cork* in the Maynooth Studies in Local History series (Dublin, 2014).





No. 164—KERRY: 'Day Place—'The most respectable locality in Tralee' by Laurence Jones and published by Four Courts Press (ISBN 978-1-80151-097-4: 78pp: illustrations: p/bk €12.95 Web Price €11.65). This book studies the occupants of Day Place, a terrace of ten Georgian townhouses in Tralee, Co. Kerry, over a 100-year period. The street was the most fashionable and sought-after address in the town and residents of the terrace were among the wealthiest and most influential individuals in the area. The economic and political transformation of Tralee – and Ireland – from 1830 to 1930 was reflected in the reins of government passed from a largely Protestant clique to a confident Catholic and nationalist middle class of entrepreneurs and professionals. This volume brings some of these colourful characters to life, uncovering their activities and attitudes and painting a picture of the rapidly changing religious and political landscape in which they lived. Laurence Jones is an English artist and historian who has lived in County Kerry for over thirty years.

The Mansfields of County Kildare



No. 165—KILDARE: 'The Mansfields of Co. Kildare—A Franco-Irish Catholic elite family and their networks, 1870-1915' by Fergus Murphy and published by Four Courts Press (ISBN 978-1-80151-098-1: 77pp: illustrations: p/bk €12.95 Web Price €11.65)

Always a real gem for the genealogist when a volume in this series is devoted to a particular family and, indeed, there have been in many

excellent family histories published in this series.

While dominated by Protestants, the nineteenthcentury landed gentry of Ireland also included a minority of Catholics. Social and marriage networks of this latter group have received little scholarly attention, and this volume helps to fill that gap.

Fergus Murphy, quotes Terence Dooley, to make a very important point regarding the "landlord class" in Ireland.. "regardless of religion, social standing or estate size, all landlords shared the same cultural values to varying extents ... exercised the same social, political and economic powers ... conferred by

the landownership in their respective localities". The "big house" was a common feature of the Irish rural landscape until the War of Independence and, of course, the Civil War.

Murphy looks at the social networks for one Catholic elite family and examines how important religion was to that family and how their marriage choices were impacted by such and the connection between their networks and education choices.

With Catholicism as a common denominator for most French and Irish people during that period, the study is based on the Franco-Irish Mansfield family in Co. Kildare. It leans largely on family and estate papers and includes a quantitative analysis of a French-language diary kept by Alice Mansfield (née De Férussac) between 1877 and 1887. The diary was transcribed, translated and analysed to provide a view of the family's social network in Ireland and France.

Fergus Murphy holds a Bachelors degree in Electronic Engineering from Trinity College Dublin and currently works as a Product Marketing Director. He received a Masters degree in History of the Family from University of Limerick in 2019 and is also a graduate of the Genealogy and Family History program in University College Dublin. Previous publications include an article titled 'The D'Oliers of Dublin City' in The Huguenot Society

PRÉCIS OF THE SEPTEMBER LECTURE

The Monthly Lecture delivered via Zoom on Tuesday 12th September 2023 was by Dr Elizabeth Stack on the wonderful work research and public educational projects undertaken by the 'Irish American Heritage Museum' at Albany in upstate New York. The Irish American Heritage Museum explores the contributions, history, and culture of Irish people in America; and fosters dialogue and exchange between America and Ireland today. sharing our stories, we strive to create connections and community between all Americans, as we appreciate and study the universality of the immigrant story in American history" Dr Stack explained.

Through both a permanent collection and a series of changing exhibitions, the Museum displays artifacts, recounts first-person stories, and explores the history of Irish immigrants and individuals with Irish heritage. The collection includes artifacts belonging to Irish American organizations, historic costumes, devotional items, and music recordings. The Museum is the repository for the National Board of the Ancient Order of Hibernians records and collections. The permanent galleries of the Museum include full-size reconstructions of an Irish cottage and a tenement apartment, supported by an Emigrant Support Programme grant from the Department of Foreign Affairs, and a scale model of a workhouse. The library has an extensive collection of books, archival materials, and records which is open to the public, and once a month a genealogist helps visitors trace any Irish roots

The Museum also hosts lectures, musical performances, cooking demonstrations and tastings, film screenings, plays and staged readings, and more. Most programmes are available both in-person and virtually, which allows them to reach viewers across the entire United States and in Ireland. The Museum was an integral force in requiring instruction in New York State's public schools about the Irish Famine of 1845-1853. The Museum is the first of its kind in America to have exhibited at the National Library of Ireland. A lively Q+A followed this very interesting presentation. Elizabeth Stack, PhD - Executive Director, joined the Museum from Fordham University where she taught Irish American History and was the Associate Director of the Institute of Irish Studies. She has presented her research at various US conferences and Ireland. A native of Listowel, in Co. Kerry. 
Our Society is a Registered Charity
