# **Principle of Public Ownership & Right of Access**

Fintan O'Toole in his OpEd 'Failure to prevent destruction of records is a further insult to those whose identities were stolen' published in 'The Irish Times' Tuesday 18th June 2024 highlights the appalling fact that the many of the records of the various "Mother & Baby Homes" and "Magdalen Laundries" are still not in state custody.

He notes the failure by successive governments to put in place effective procedures, by which, to locate, centrally record and ensure the proper preservation of these invaluable registers and records.

According to O'Toole "To treat these records with such contempt is to repeat the contempt shown by Church and State to thousands of women and children" and, indeed, his OpEd makes for very grim reading about the discovery of records in derelict, damp, leaky buildings subject to vandalism and infested by pigeons. These documents, he rightly points out "are not of merely historical interest" but they "are the traces of real lives. They contain information that may Irish people still need in order to understand who they are and where they came from'

This Society has campaigned, since its foundation in 1990, Ihis Society has campaigned, since its foundation in 1990, for the protection and preservation of such records, indeed, during the Seanad Éireann debate on what would become the 'National Cultural Institutions Act, 1997', the Society successfully had sections 49 and 50 of this legislation include records of genealogical interest, for example, school, parish, burial, and cemetery registers, and provisions for copying, prohibitions on export etc. Although, this legislation was passed by the Oireachtas in March 1997, shamefully, it was not commenced until May 2005. shamefully, it was not commenced until May 2005

The following is the text of the resolution adopted at our Annual General Meeting held on Tuesday 14<sup>th</sup> October 1997 in An Cultúrlann in Monkstown, Co. Dublin.

'Principle of Public Ownership & Right of Access' - That, this meeting fully endorses the definition of our genealogi-cal heritage as meaning "records of birth, baptism, marriage and death; burial records; census returns; testamartage and aeam, ournal records, census returns, lessa-mentary, property and school records and maps; biog-raphies and family histories; heraldic devices; clan/sept and local histories; gravestones and the inscriptions there-on and all other associated records", and in doing so, affirms the principle of public ownership and right of access to this heritage by the people of Ireland and her diaspora. In addition, the meeting instructs the incoming Executive Committee to ensure that the Society shall only affiliate with such organisations and bodies endorsing this 'Principle of Public Ownership & Right of Access'. (Text published in Vol. 2 No. 11 (November 1997) issue of 'The Genie Gazette')

Just over ten years after the adoption of the above principle, the editorial of this newsletter in July 2008 (Vol. 3 No. 7), highlighted the continuing campaign by the Society on this vital issue for genealogists and other researchers.

The following two excerpts from the 2008 editorial noted some considerable progress, but with much more work to do.

[All the Society's policies are based on this principle. Indeed, so strongly did our members endorse this fundamental principle in 1997 that they made acceptance of the principle a precondition for the Society's affiliation with other heritage organisations. Indeed, back in 1997/8 some others involved in Irish genealogy refused to endorse this principle on the mistaken belief that it somehow interfered with lawful ownership or copyright. However, over time such fears were seen to be utterly groundless. Although, the Society pioneered the acceptance of this principle, over the years it has become the widely accepted bedrock of good governance and best practice in the management, custody, and delivery of heritage services.]

[The various custodians of these archival collections have a duty to the people of Ireland to ensure the security, proper care, and management of the collections and many, if not all, take this responsibility very seriously indeed. However, there is no agreed national policy or coordinated approach to the management and care of the archival collections held by private institutions in the State. Indeed, each of the national repositories, depending on the primary legislation concerned, makes its own provisions, and adopts its own policies in respect of its archival collections.]

Now nearly twenty-seven years since the Society's adoption of the 'Principle of Public Ownership & Right of Access', clearly this fundamental principle requires a expression by strengthening the provisions of the 1997 Act. Also, Fintan O'Toole's piece in 'The Irish Times' highlights the urgent need to utilise the powers provided by the 'Birth Information & Tracing Act, 2022' to establish a properly resourced unit specifically tasked with the locating and





# The NUI WW1 Centenary Roll of Honour & Essays



The national commemoration of the "Decade of Centenaries" has been widely praised as having been inclusive, respectful, and sensitive to the communal and familial memories and experiences of the turbulent years that ushered in the birth of an independent Ireland. The organisers and, particularly the academic historians who advised on the interpretation of the events being commemorated, ensured that each event was reflective, interpretative, and educational.

The care and attention paid to nomenclature, symbolism, phraseology, and historical accuracy allowed for a dignified memorialisation of a shared and often troubled history, especially at local level. No doubt, this included an awareness of the need for certain events not to simply mirror the type, tone and focus of such held elsewhere to commemorate, for example, the First World War. That this was achieved is a credit to all concerned.

This forthcoming publication by Four Courts Press must be viewed in that context. 'The National University of Ireland First World War Centenary Roll of Honour and Essays' by Ronan McGreevy & Emer Purcell is due to be published by Four Courts Press (ISBN: 978-0901510-990 : P/bk : 400pps : Full Colour : Price: €30.00 : Web. Price: €27.00) in September 2024. This book

is very likely to be quickly sold out and therefore, pre-publication ordering is strongly advised.

In 1919, the **National University of Ireland** compiled a war list of all students, graduates, and staff of University College Cork, University College Dublin, and University College Galway, who had died or served in the "Great War". The original *Honour Roll* is reprinted here along with a collection of explanatory essays and with a substantive introduction accompanied by a selection of individual personal profiles brings the men recorded in the roll to life. In addition to the NUI's list, the *Honour Roll of the Royal College of Surgeons in Ireland* is also reproduced along with an essay on NUI doctors who served during the war. For the first time, a list of the chaplains from St Patrick's College Maynooth is presented and their lives examined. NUI's women students, graduates, and staff and the ways in which they contributed to the war effort is also explored.

#### THE GORE ROLL OF ARMS

The Gore Roll and the Committee on Heraldry's Roll of Arms' by Harold Bowditch with this volume by Nathaniel Lane Taylor was published by NEHGS in association with Palfrey Press—Antiquarian Tomes in May 2024. This beautifully produced volume has a foreword by **Brady Brim-DeForest**, who very kindly provided the patron support for this important publication; a preface by Ryan J. Woods with an introduction by D. Brenton Simons OBE.

The Gore Roll of Arms, the earliest known roll of arms in America, was the work of John Gore (1718–1796), a coach painter of Boston. During the

nearly 70 years that the *Gore Roll* was lost or missing, copies of it were created by Isaac Child in 1847 and Harold Bowditch in 1926.

The original roll and these two copies are reproduced together for the first time, in full colour, in this volume. The pages of the *Gore Roll* are accompanied here by relevant artwork from *The Book of Coates and Creasts: The Promptuarium Armorum*, a roll of arms created between 1602 and 1616 by William Smith, Rouge Dragon Pursuivant of Arms in Ordinary.

Dr. Bowditch's insightful monograph, published by the Rhode Island Historical Society in 1936, is presented alongside the *Gore Roll* paintings, for the first time.

This special edition provides fresh perspectives on heraldic traditions in North America and it is a lavishly illustrated production with high quality images of the original roll that has some wonderful information on Irish armigers.

Also included, as an appendix, is Bowditch's 1944 Colonial Society essay, 'Early Water-Color Paintings of New England Coats of Arms'.

Published in collaboration with Palfrey Press for the 36th International Congress of Genealogical and Heraldic Sciences which will be held in Boston, Massachusetts, USA from September 24th to 28th 2024. Cathaoirleach John Goggins, MGSI, will represent the Genealogical Society of Ireland at this prestigious event – the first time it is being held in North America. # James Scannell Reports...

#### THE OLD DUBLIN SOCIETY

The Old Dublin Society is delighted to share its good news with everyone who has an interest in local history and heritage in Ireland.

The Heritage Council has agreed to award a grant, under the Community Grant Scheme, towards the cost of cataloguing a collection of c.700 books. This enables them to be made widely available for reference by historians, students and everyone who is interested in finding out more about an aspect of their heritage and surroundings.

The Old Dublin Society was founded in 1934 - the first local history society in Dublin - to promote the study of history and archaeology, particularly relating to the City and County of Dublin. One of its principal objects has been to assemble a collection of books, documents and other records which have a historical interest.

For many years the Society was based in the former City Assembly House in South William Street - many of you will remember the Civic Museum there, which was a joint venture with Dublin Corporation.

The City Assembly House had become structurally unsound by the early 2000s; the Civic Museum was closed and the Old Dublin Society had to make new arrangements. The Royal Dublin Society agreed to house the library collection and the catalogue was upgraded to international professional standards.

In the intervening years, donations of suitable books have been accepted from members of Old Dublin Society and, in 2020, a very substantial donation was accepted from one particular donor. Work has now started on the cataloguing of all these donations and the creation of an integrated catalogue of about 1,500 books. This catalogue will be completed and made available online by autumn 2024, enabling them to be within reach of everyone.

The result will be a unique collection of books mainly relating to the history and heritage of Dublin - all in one catalogue and under one roof i.e. The Old Dublin Society Collection, housed in Royal Dublin Society library.

Access to the collection will be available to everyone through the RDS Library & Archive catalogue which is freely available to the public via the RDS website https://library.rds.ie or through a link in the Library & Archive section of https://olddublinsociety.ie/.

The Old Dublin Society is grateful to the Heritage Council for this funding award. The Old Dublin Society will announce when the work has been finalised.

## PRÉCIS OF THE JUNE LECTURE

On Tuesday June 11th 2024 at our Evening Open Meeting we were delighted to welcome as our Guest Speaker, **Davy Holden**, a south County Kilkenny based Local Historian, Video Creator, Author, Musician and Public History Educator, who explored the subject 'Irish History and the Genealogist'.

He very succincily brought us through the subject by reference to his own work and how he decides what to cover, what period and what aspect of the event or period to highlight in each video or podeast. Davy's YouTube videos have received over 15 million views since 2014. His YouTube channel (see page 2) has around 600 videos and short reels on a range of subjects including, Irish history, placenames, historical events, local history - the townlands - history all around us - in the names of places, in our surnames and in our folklore, music and song. With a lifelong interest in Irish history inspired by his own father's love of history, Davy has researched and presented videos and short reels on many aspects of our history to address, as he sees it, the possible waning of the intergenerational understanding, appreciation, and knowledge of our past.

He strongly believes in the use of social media to connect and, possibly reconnect, people with the history of our country, our local history, our language, our music and, of course, our genealogical heritage. His approach to each subject in his videos, given the restrictive nature of the medium, is a fact-based contextualisation of the event or period. These "bite-sized" segments provide a very useful overview to both inform the audience and to instil a curiosity to learn more about each subject. This is the essence of public history education.

He has written two eBooks - 'The Ambush in New York City' and 'The Top 10 Irish Rebel Songs' - the latter was

# NEW CATHAOIRLEACH AT DLR

The national HQ of this Society is located in the area of Dublin covered by **Dún Laoghaire Rathdown County Council.** The County Council has been a wonderfully consistent and generous supporter of the Society since the Council was established in 1994.



Following the Local Elections held in Ireland on June 7th 2024, the County Council held its Annual General Meeting on Friday June 24th 2024, at which, Cllr. Jim O'Leary (Fine Gael) was elected as Cathaoirleach (Chairperson) and Bangladeshi born, Cllr. Kazi Ahmed (Fine Gael) as

Leas-Chathaoirleach (Vice-Chair).

At the AGM glowing tributes were deservedly paid to the previous Cathaoirleach, **Denis O'Callaghan** (Labour) who retired after thirty years of public service as a very active and dedicated Councillor. We wish Denis a long, happy, healthy and active retirement—maybe family history research is on the cards? As the Council has a number of important policy documents up for review, amendment and adoption in this term, the Board wishes the new Cathaoirleach, Leas-Chathaoirleach and all of the County Councillors, newly elected and returning, every success.

Maybe one of the issues the new "first citizen" of the County should address is the apparent absence of the coat-of-arms of Dún Laoghaire Rathdown on the Council's website—more than likely an oversight. The arms, granted by the Chief Herald of Ireland in 1994, represent the new county established in that year, its people and their democratically elected local government (Article 28A of the Constitution). However, the logo introduced in 2005, has now apparently completely replaced the arms on the website, which wasn't the original intention of the Council management. Indeed, at a Strategic Policy Committee (SPC) meeting held in September 2005, the stated reason for the introduction of a new corporate logo was to "reflect the modern, professional approach of the local authority" and that, the status of the arms would be unchanged.

Councillors and SPC representatives said the arms represented the Council and local democracy and that the logo "appeared to represent the delivery of services by the Council". (see 'The Genie Gazette' Vol. 10, No. 9, September 2005 on the GSI website) The citing of the Official Languages Act, 2003 as a reason for the logo's introduction was totally debunked by a simple reference to the Act.

The issue arose again during the design phase of the new chamber, which finally opened in late 2018, with Councillors insisting that the arms be used instead of the logo in the design and the furnishings. As an organisation devoted to the promotion an awareness, appreciation and knowledge of our heraldic heritage, the Society would urge the new Cathaoirleach to ensure that the County Arms are prominently and appropriately displayed on the Council's website and in its publications.
